Mayor Hartwell explained to the Governing Authority that the resolution for the Electrical Rates fail to include the 10% Senior Citizen Discount. Motion by DAVID DUPUIS, seconded by ALTHEA WILLIAMS and carried to amend Resolution 11-2007 to read "ALL RESIDENTIAL CUSTOMERS WHO HAVE REACHED THE AGE OF SIXTY-FIVE (65) YEARS SHALL RECEIVE A TEN (10%) PERCENT DSCOUNT FOR MONTHLY ELECTRICAL CHARGES PROVIDED THAT THEIR UTILITY BILLING STATEMENT IS PAID BY THE FIFTEENTH OF THE MONTH SAID STATEMENT IS RENDERED.
