Police Chief Benjamin Touchet requested that Jamin Meaux be reinstated into the reserves as a part time officer with the Gueydan Police Department. Motion by GALE SMITH died for a lack of a second to reinstate Jamin Meaux on the Reserves with the Gueydan Police Department.

Police Chief Benjamin Touchet turned in his resignation effective January 24, 2007 at 6:30 p.m.

Officer Barton Kibodeaux turned in his resignation, along with reserve officers Kimberly Kibodeaux and Greg Richard effective January 24, 2007 at 6:30 P.M.

No action was taken on these resignations at this meeting.

Mayor Chris Theriot presented his resignation to the governing authority. Motion by DAVID DUPUIS, seconded by JUDE REESE and carried to accept Mayor Theriot's resignation effective January 25, 2007.

Mayor Theriot recommended that CHARLOTTE VENABLE-HARTWELL Mayor Pro-Tempore be appointed to fulfill the duty until a special election could be held. Motion by GALE SMITH seconded by JUDE REESE and carried that CHARLOTTE VENABLE-HARTWELL Mayor Pro-Tempore to fulfill the duty of as of January 25, 2007 until a special election could be held on October 20, 2007.
